

Regulation Regarding Advanced Standing Admissions, Etc. to the University of Aizu

Article One

(Objective)

- 1.1 Based on provisions of Article 19 of the PREFECTURE RULING ON THE UNIVERSITY OF AIZU (hereinafter referred to as the "RULING"), advanced standing admissions and transfer admissions (hereinafter referred to as the "ADVANCED STANDING ADMISSIONS, ETC.") shall be determined according to this regulation. However, advanced standing admissions for applicants from the University of Aizu Junior College Division shall be provided for separately.

Article Two

(Period of ADVANCED STANDING ADMISSIONS, ETC.)

- 2.1 The period of ADVANCED STANDING ADMISSIONS, ETC. shall be the beginning of an academic year. However, the period of transfer admissions may be the beginning of a semester.

Article Three

(Application Procedure for ADVANCED STANDING ADMISSIONS, ETC.)

- 3.1 Those who are to apply for ADVANCED STANDING ADMISSIONS, ETC. to the University of Aizu shall apply to the University President by submission of documents described below along with examination fees by the prescribed date.
- (1) Admissions application (prepared by the relevant applicant using the designated form.)
 - (2) Certified transcript (prepared by the president of the university, etc. which the applicant attended/graduated from.)
 - (3) For those applying for transfer admissions, a written permission from the university at which the applicant is currently enrolled; for those applying for advanced standing admissions, a certificate of (expected) graduation or a certificate of enrollment
 - (4) Other documents recognized by the University President as necessary

Article Four

(Selection Method)

- 4.1 Selection regarding applicants for ADVANCED STANDING ADMISSIONS, ETC. shall

be conducted by the ADVANCED STANDING ADMISSIONS, ETC. Selection Committee. Members of this Committee shall be organized of members whom the University President appoints from members of the Entrance Examination Committee.

- 4.2 The ADVANCED STANDING ADMISSIONS, ETC. Selection Committee shall conduct selection based on an achievement test, document examination, and an interview. The University President shall make a decision on the ADVANCED STANDING ADMISSIONS, ETC. after deliberation by the Faculty Assembly, based on the selection result.

Article Five

(Admission Procedure)

- 5.1 Individuals who receive a notification of determination on ADVANCED STANDING ADMISSIONS, ETC. shall take ADVANCED STANDING ADMISSIONS, ETC. procedures by submission of prescribed documents with payment of the admission fees by the designated date.
- 5.2 The University President can permit ADVANCED STANDING ADMISSIONS, ETC. for those who have completed admission procedures described in Article 5.1 above.

Article Six

(Recognition of Credits Earned prior to Admission to the University of Aizu)

- 6.1 Academic credits earned by individuals who have been admitted to the University of Aizu upon completion of subjects at the universities, etc. which the individuals attended/graduated from can be recognized by the University President as academic credits earned for subjects at the University and those required for their graduation, after deliberation by the Academic Affairs Committee.

Article Seven

(Department Class Level for ADVANCED STANDING ADMISSIONS, ETC.)

- 7.1 The department class level for individuals who are admitted to the University through ADVANCED STANDING ADMISSIONS, ETC. shall be the second-year or the third-year level, depending on the situation regarding recognition of academic credits earned by the individual at the university, etc. which he/she attended/graduated from as those earned at the University.

Article Eight

(Academic Residence Requirement and Enrollment Period Limit)

- 8.1 Individuals who have been admitted to the University through ADVANCED STANDING ADMISSIONS, ETC. shall not be enrolled at the University for a period exceeding the number of years equivalent to the number of years as twice as long as the number of years remaining before expected graduation according to a predetermined duration of enrollment.

Article Nine

(Tuition)

- 9.1 The amount of tuition for individuals who are admitted to the University through ADVANCED STANDING ADMISSIONS, ETC. shall be the same as that for students enrolled in the same department class level with the relevant individuals.
- 9.2 Individuals who are admitted to the University through ADVANCED STANDING ADMISSIONS, ETC. shall make payment of tuition by designated dates.

ADDITIONAL PROVISIONS

This regulation shall be enforced as of April 1, 2006 .
