

**UNIVERSITY GENERAL PLAN ON THE ESTABLISHMENT OF THE UNIVERSITY OF  
AIZU COOPERATIVE RESEARCH, ETC. ACCEPTANCE DELIBERATION  
COMMITTEE**

**Article One**

(Establishment Objective)

1.1 The University of Aizu Cooperative Research, Etc. Acceptance Deliberation Committee (for the purpose of this general plan, hereinafter referred to as "COMMITTEE") shall be established for the purpose of deliberating the acceptance of University of Aizu (for the purpose of this general plan, hereinafter referred to as "UNIVERSITY") cooperative research, commissioned research, and grant donations.

**Article Two**

(Organization)

2.1 The members of the COMMITTEE shall be as follows:

- (1) Professors selected by and from the Faculty Assembly: a few;
- (2) Professors selected by the Graduate Department Councils a few;
- (3) The Director General of the Administrative Office.

2.2 The term of office of committee members shall be two years; these members can be reappointed. However, the term of office of those members initially becoming members to fill a vacancy shall be the remainder of the vacated term.

2.3 The positions of Committee Chairperson and Committee Vice Chairperson shall be established within the COMMITTEE and shall be determined by the mutual election of the committee members.

**Article Three**

(Convocation, Etc. Of The COMMITTEE)

3.1 The Committee Chairperson shall supervise affairs concerning the COMMITTEE.

3.2 The Committee Chairperson shall convoke the COMMITTEE meeting and serve as the chair thereof.

3.3 Should the Committee Chairperson be unable to fulfill his/her duties, the Committee Vice Chairperson shall fulfill these duties on his/her behalf.

**Article Four**

(Matters For Deliberation)

4.1 The COMMITTEE shall deliberate the following matters:

- (1) Matters concerning the acceptance of cooperative research and commissioned

research at the UNIVERSITY;

(2) Matters concerning the acceptance of grant donations at the UNIVERSITY; and

(3) Other matters concerning those necessary for the purpose of accomplishing the objectives of the COMMITTEE.

#### **Article Five**

(Attendance By Related Individuals)

5.1 The Committee Chairperson, in situations in which he/she recognizes doing so as necessary, may require the attendance of related nonmembers for the purpose of requesting explanations from such nonmembers or having them provide opinions.

#### **Article Six**

(Miscellaneous Affairs)

6.1 Miscellaneous affairs concerning the COMMITTEE shall be performed by the Collaboration and Assistance Group of the Administrative Office.

#### **Article Seven**

(Supplemental Provisions)

7.1 Other than provided for by this general plan, necessary matters concerning the administration of the COMMITTEE shall be determined separately by the Committee Chairperson.

#### **ADDITIONAL PROVISIONS**

This general plan shall be enforced as of April 1, 2006.
