

## **University Regulation Regarding Readmission to the University of Aizu**

### **Article One**

(Objective)

- 1.1 Readmission based on provisions of Article Twenty of the RULING ON THE UNIVERSITY OF AIZU (hereinafter referred to as the “Ruling”) or Article Eighteen of the RULING ON THE UNIVERSITY OF AIZU GRADUATE SCHOOL (hereinafter referred to as the “Graduate School Ruling”), shall be determined according to this regulation.

### **Article Two**

(Conditions for Applying Readmission)

- 2.1 Those who enrolled in but later withdrew from the University are eligible to apply for readmission. Those who were dismissed from the University based upon Article 3 of the Regulation Concerning Disciplinary Punishment of Students of the University of Aizu or were expelled shall not be eligible to apply for readmission.

### **Article Three**

(Application Procedure for Readmission)

- 3.1 Those who are to apply for readmission to the University of Aizu shall apply to the University President by submitting the documents described below along with examination fees.
  - (1) Application Form for Readmission: This must be prepared by the applicant using the predetermined form.
  - (2) Personal Statement for Readmission: This must be prepared by the applicant using the predetermined form.
  - (3) Other documents recognized by the University President as necessary.
- 3.2 Application period for readmission shall be before the date six months before the first day of the quarter (limited to the 1st or the 3rd quarter) when the applicant wishes to be readmitted to the University.

### **Article Four**

(Selection Method)

- 4.1 Upon receipt of an application for readmission, the University President shall establish a Selection Committee. This Committee shall be organized of members whom the University President appoints from members of the Entrance Examination Committee or the Graduate School Entrance Examination Committee.
- 4.2 The Selection Committee shall conduct selection procedures through an interview and

a written test as necessary after examining the applicant's Application Form, Personal Statement for Readmission, his/her academic performance during enrollment at the University, etc. The University President shall then make a decision on the readmission through deliberation by the Faculty Assembly or the Graduate School Faculty Assembly, based on this examination result.

#### **Article Five**

(Recognition of Academic Credits Earned prior to Readmission to the University of Aizu)

- 5.1 Academic credits earned by those readmitted to the University of Aizu during their prior enrollment period can be regarded as part of the credits required for graduation or completion by the University President through deliberation by the Academic Affairs Committee or the Graduate School Academic Affairs Committee.

#### **Article Six**

(Year of Readmission)

- 6.1 The year of readmission shall be that at the time of withdrawal. However, in the case of those granted readmission for whom readmission to the year at the time of withdrawal is not appropriate based on the academic credits earned, academic performance, etc. before withdrawal, the president may readmit said individuals to an appropriate year.
- 6.2 The readmission period for those granted readmission to the University of Aizu shall be the beginning of the 1st or the 3rd quarter. The provisions of the University Regulation on the Completion of the University of Aizu Studies and other regulations enforced after their readmission shall apply to these students.

#### **Article Seven**

(Enrollment Period Limit and Period of Leave of Absence)

- 7.1 Those readmitted to the University shall not be enrolled for a period exceeding twice the standard period of study of the School of Computer Science and Engineering or three times that of the Graduate School. In addition, the period of a leave of absence after readmission shall not exceed the period stipulated in Article 29, Paragraph 3 of the Ruling or Article 29, Paragraph 3 of the Graduate School Ruling including the period of a leave of absence taken before withdrawal.

#### **Article Eight**

(Readmission Procedures)

- 8.1 Individuals who receive a notification of determination on readmission shall take readmission procedures by submission of prescribed documents with payment of the readmission fees by the prescribed date.
- 8.2 The University President can permit readmission for those who complete readmission

procedures described in Article 8.1 above.

**Article Nine**

(Tuition)

- 9.1 The amount of tuition shall be the same as that for students enrolled in the same department class level.
- 9.2 Individuals who are readmitted to the University shall make payment of tuition by a predesignated date.

**ADDITIONAL PROVISIONS**

This regulation shall be enforced as of April 1, 2006.
